Re: Downtown Woodstock Streetscape Master Plan Implementation Options

AIM

To obtain City Council direction regarding the implementation of the Downtown Woodstock Streetscape Master Plan.

BACKGROUND

In 2021 City Council provided budget approval for \$144,000 to be used to create a Downtown Streetscape Master Plan. In the late summer of that same year, the contract to undertake community consultation and prepare the plan was awarded to MHBC Planning, Urban Design and Landscape Architecture, with work beginning immediately.

One of the top priorities identified in the Downtown Development Plan was the creation of this Streetscape Master Plan. The rationale for developing a comprehensive streetscape master plan was to identify a long-term vision for streetscape improvements that can be implemented in a coordinated fashion. As such, the objective of the plan is to provide a framework for attaining the goals of the City in the downtown and includes a preferred concept layout/schematic, and recommended materials. The plan also includes a detailed concept that articulates the redevelopment of the City's Museum Square and City Hall Block. The concept for a new Museum Square proposes a larger, more programable public space which may be enjoyed by Woodstonians year-round. The Downtown Woodstock Streetscape Master Plan (DWSMP) was adopted by City Council in October 2022.

As part of the 2023 Capital budget, Council approved funds to complete the detailed design to implement redevelopment of Dundas St between Light St./Brock St. and Wellington St. Since obtaining budget approval, City staff put out an RFP for a multidisciplinary team to complete the detailed design of the functional plan that was presented in the Downtown Woodstock Streetscape Master Plan. City staff began work in June with the consultants to plan out details of the streetscape. Streetscape includes removal of all of the existing features from the north building faces to the south building faces to install new sidewalk, street lighting, street furniture and landscaping. Although detailed drawings are not yet completed, based on preliminary design, a construction cost estimate of \$6,500.000 was presented to Council to complete the work between Light St./Brock St. and Wellington as part of the 2024 Capital Budget.

At the December 14, 2023 City Council meeting, City Council passed the following motion:

"That Project INF00138 Downtown Revitalization be removed from the 2024 Capital Budget and the 2025-2028 Capital Forecast and considered at the regular meeting of Council held on March 21, 2024 when Council will have a better understanding of the overall tax levy increase in 2024;

And further that staff be directed to prepare a report for the March 21, 2024 Council meeting outlining options to reduce the scope and the cost of the project;

And further that staff be directed to undertake community consultation, including a survey, outlining the specifics of the project and associated costs, and seeking feedback from the public on advancing the project."

COMMENTS

Options for going forward can be divided into two categories: scope (what work is completed) and timing (when the work is completed).

Recognizing that Dundas St was resurfaced from Vansittart Ave to Huron St in 2018/2019, and the existing pavement has a number of years of life left in it, restricting the work to the areas between the existing curb and building face to preserve the existing pavement was considered as an option. However, this option does not allow for the full improvements such as bump outs for transit stops or pedestrian crossings that are integral in the current design. Staff is not confident that cuts into the existing pavement could fully be avoided due to placement of street light wire, placement of soil cells or repair of existing curb. Pavement cuts allow water through the pavement resulting in accelerated deterioration. Limiting the work area would result in a diminished streetscape plan. A reduced plan would not have the impact or effectiveness that a full streetscape plan would have. In addition, revising the work scope to limit the work to behind the curb does not conform with the DWSMP that was adopted by Council. Revision of the DWSMP should be approved by Council following further study. For these reasons, this option was not investigated any farther and is not recommended by staff.

In addition to scope of work options, the City also has options for staging or timing of the work. The options for this are:

- A. Delay the project.
- B. Reduce the project area.
- C. Continue with the current direction of full streetscape between Light and Wellington. See description of Option 3 below.

Option 1 - Replace sidewalk paving stones with concrete sidewalks

Option 1 involves only removing paving stones and replacing them with a concrete sidewalk. This would be a bare minimum option of not improving the aesthetics of the downtown area (i.e. not following the adopted DWSMP). The existing paving stones are failing, creating tripping hazards and an increased amount of maintenance work to address them. The cost estimate to do this in the area from Light to Wellington is approximately \$475,000. This work could be completed in 2024, however this option does nothing to address the objectives of the DWSMP. To replace the paving stones outside of the current area to Vansittart to Beale/Bay (with some minor small sections east to Huron) would cost another \$625,000. Delaying or not completing the streetscape portion of the DWSMP would not impact the proposed Museum Square improvements. This work is independent (in large part) from the Dundas streetscape work and could occur at any time Council wishes.

Option 2 - Complete the full streetscape master plan work in 2024 and 2025

Option 2 would implement the recommendations of the DWSMP between Light/Brock and Wellington in line with current direction. This option creates a more inclusive and inviting

atmosphere in Downtown Woodstock. It implements and improves accessibility and flexibility by introducing rolled curbs which will allow for more seamless integration of downtown patios and other sidewalk activities. This option also improves lighting, seating, landscape and waste/recycling opportunities. Although the DWSMP showed this reconstruction happening in three separate phases, this option would have the whole project done as one large phase. The original estimate for the work between Light/Brock and Wellington was approximately \$4M. The construction cost estimate at the time of capital budget submission was estimated to be \$6.5M. However, based on recent information received from the consultant, this estimate is now \$7.4M. Staff has been working on proceeding with this option since budget approval was provided in March of 2023. The anticipated schedule for this work is to complete the design and tender the work in early summer 2024. Construction could then start in late summer with a completion date in summer 2025. Due to bridging the project over two construction seasons, there may be the risk of some work being unfinished over the winter season as well as larger impact to business access. A multi-year project will also impact the feasibility of holding Streetfest.

Option 3 – Delay the project until it is more economically feasible

Council could decide to delay the streetscape project until it feels that the project is more economically feasible. One option to consider would be to create a reserve account to start putting money aside each year until enough is saved to fund the project. This reduces the burden on the tax payers in the short term. The downside is that although there may be interest savings on debt, inflation may reduce these savings due to higher costs when the work is performed. Each year the provincial and federal governments announce a variety of funding programs for municipalities. If the design and tender packages are completed, if this project were to qualify for such a funding program and be successful in obtaining approval, this might be another option for funding. Delaying the streetscape portion of the DWSMP would not impact the proposed Museum Square improvements. This work is independent (in large part) from the Dundas streetscape work and could occur at any time Council wishes.

Option 4 – Divide the work into smaller phases that can each be completed within a single construction season

The current plan is full streetscape between Light/Brock and Wellington as one project starting in 2024 and finishing in 2025. This project area could be broken down into separate sections or contracts to be completed over a few years. This approach matches what is shown and recommended in the DWSMP. The DWSMP shows this work being done in 3 stages: Brock to Graham, Graham to Riddell and Riddell to Wellington. Scaling back on the project area to reduce it to Riddell to Wellington more accurately matches the DWSMP and would be less costly initially. Reducing the project area provides a full and complete streetscape and will give residents and the business owners a feel of what the fully completed project will look and feel like. The accessibility concerns and improvements to street lighting, street furniture, etc. would still be met. Staging the full streetscape also provides the opportunity to adjust future sections as desired and to learn from any issues during the first phase so that they can be addressed in subsequent phases. After phase one is completed, subsequent phases could be scheduled so as to not interfere with Streetfest. The design work currently being performed would continue and would not be wasted effort. If Council wishes to proceed with Riddell to Wellington in 2024, they can proceed with another section in 2025 or any subsequent year or years. Considering that the current schedule anticipates construction to extend into 2025, this means that other sections would not actually be delayed. Construction cost to complete a full streetscape between Riddell and Wellington was estimated to be approximately \$2.6M +/-. Staff recently

received a construction cost estimate based on 30% complete drawings of \$2.7M for this phase of the work.

Please note that none of the costs discussed above include cost for work outside of the Dundas St. streetscape project area of Light Street to Wellington Street. The DWMSP also recommended that Dundas streetscape improvements be completed between Vansittart and Light and between Wellington and Bay as well as the redevelopment of Museum Square. The DWMSP originally estimated these other costs in the neighbourhood of \$11M. There is a large uncertainty with this number considering that the developable area of Museum Square has grown and a new study needs to be completed to relook at this portion of the DWMSP. Inflationary cost increases will also impact the price. In Staff's opinion, final costs to implement all of the DWMSP recommendations could be upwards of \$20M.

Survey

At the direction of Council, staff prepared a survey to gather input from the public into how they would like to see the implementation of the streetscape project proceed. The survey was available online from February 12 to March 3. Hard (paper) copies of the survey were available upon request. A total of 859 responses were received.

The survey asked respondents how often they visited downtown and why and how much they agreed or disagreed with several statements related to the downtown and streetscape project. An overview of the 4 options, including costing, was provided and respondents were asked which option they supported for implementing the downtown streetscape. Respondents could also choose the response "I do not support moving forward with the Streetscape Master Plan". The responses are outlined in the following table:

Respondents were also asked if there was anything else they wanted to share with Council. Of the 386 comments received, at least half mentioned concerns with safety, homelessness, drug use and other social issues. Other notable themes included:

- Parking (more parking, increase parking fees, decrease parking fees)
- Addressing vacant buildings and maintenance issues
- Improving the variety / type of stores
- Housing (need to increase residential densities and bring more people downtown)

The complete survey results can be found in Appendix A of this report.

Museum Square

In addition to the options for proceeding with the advancement of the streetscape portion of the DWSMP, the Museum Square portion of this plan should also be addressed. Since the completion of the DWSMP, there have been a number of changes that impact the Museum Square recommendations. The City has recently purchased 478/484 Dundas. This, along with acknowledgment that City Hall needs an addition to provide a more accessible and secure building and larger council chamber and staff space, has made the current plan for this area shown in the DWSMP obsolete. As a result, staff recommends that Council consider using 2024 to restudy this area to include these factors. The revised plan would include a comprehensive plan and preliminary drawings for a City Hall addition and revised outdoor improvements that would include the space currently used by 478/484 Dundas St. The possible City Hall addition work will study the existing layout and space usage to develop possible floor plans and renderings to address current and future needs. This additional space may provide more opportunities for programming and entertainment to make downtown a destination point. It is estimated that a revised report will cost approximately \$60,000.

RECOMMENDATION

(Council to choose one of the following 4 options)

That Woodstock City Council direct staff to proceed with Option 1 and approve a revision to the 2024 Capital Budget to include \$475,000 for Project INF00138 to be financed by the Capital Reserve and \$625,000 be included in the 2025 Capital Budget Forecast.

OR

That Woodstock City Council direct staff to proceed with Option 2 and approve a revision to the 2024 Capital Budget to include \$7,400,000 for Project INF00138 to be financed by debenture;

OR

That Woodstock City Council direct staff to proceed with Option 3 and refer a request for an annual contribution to the Downtown Redevelopment Reserve Fund as part of the Revenue Fund Budget approval report;

OR

That Woodstock City Council direct staff to proceed with Option 4 and approve a revision to the 2024 Capital Budget to include \$2,700,000 for Project INF00138 to be financed by debenture;

AND

And further that City Council direct staff to proceed revising the Museum Square portion of the Downtown Woodstock Streetscape Master Plan to incorporate the demolition of 478/484 Dundas and a City Hall expansion and approve an additional \$60,000 for Project INF00138 to be funded from the Capital Reserve.



Q1: What is your connection to Downtown Woodstock?



Q2: In the past 12 months, how often have you come to Downtown Woodstock?




Q3: Please indicate the degree to which you agree or disagree with the following statements:








Q4: Please indicate the degree to which you agree or disagree with the following statements.






Q4: Please indicate the degree to which you agree or disagree with the following statements.

Completing the work proposed in the streetscape master plan (improving the sidewalks, lighting and street furniture) will:





This project should absolutely be a priority for Council. Feels like we have already been asked to give feedback multiple times over last 5 years and still waiting to see more action taken to improve the downtown.

To create a vibrant core, you need people. Sidewalks & lighting make an area more accessible to everyone. Redoing the sidewalks is also an opportunity to address accessibility to businesses with a raised entrance threshold. By grouping needs, cost sharing and grants barriers can be removed for all abilities.

There is still momentum with the excitement of the Downtown masterplan, and we can again be proud of Downtown like so many smaller cities/towns across Ontario. Please make this one of the legacies of this council, as the impact on the future of Downtown Woodstock will be measurable.

Fulfil your campaign promises and proceed with with the full plan. Other municipalities have competed Streetscape and Beautification and their downtowns are so much more vibrant, safe/accessible, and thriving!

Add significant bike parking and you've sold me.

The price tag on this project sickens me, especially considering all the services and amenities we are lacking already. Can new garbage cans be installed without replacing the lights? Can additional forms of lighting be used without changing what is already there (string lights, art installations, etc)? I would be supportive of small upgrades, not tearing up the streets and rebuilding everything entirely (think a new coat of paint and hardware vs a whole kitchen reno) with the HOPE that new business owners and patrons show up. I've lived in many cities, big and small, and the thing that brings people downtown are apartments, restaurants, stores and essential services, not the sidewalks, banners or flower pots.

Looking for a small town who recognizes their retirees, doesn't allow unsightly make shift encampments & then taxes it's citizens to cleanup someone else's mess, and has a tax structure that we can afford.

Put more best cops in downtown core to move out the undesirables who are bad for business. The homeless problem is a DRUG problem exacerbated by the police force administering naxolone instead of doing real police work. If the city wants to help itself lobby the other levels of government to bring back treatment centres and/or more jails. Until people feel safe no city in this country will have a safe downtown. When in downtown Edmonton one summer day we saw 3 takedowns by city police.



Council needs to identify improvement needs & budget into a reserve fund - Rome wasn't built in a day - divide projects as they are affordable & funds are in the Reserve Fund. Personal household projects are done that way...time the council took note. Address the derelict building landlord issue - don't give them tax breaks, make them accountable, if a personal residence was left in this deplorable state - the City would be all over it. Stop making the taxpayer pay for others mistakes. Clean up the storefronts, get some continuity in signage etc (take a look at Orillia as a good example), attract some business' that would actually draw people & more business' in - enough with tattoo parlours, Vaping & Cannabis stores, quickie loan establishments. Get some business downtown to help pay the taxes & the improvements. Woodstock taxes are beyond too high. If people could afford the taxes or the rents needed to be charged to pay taxes, maybe they wouldn't be forced out onto the streets. It is bad enough that Oxford County budget is so high - when are they going to start cleaning up encampments & the mess left behind....again, taxpayers didn't create the problem, but boy are we paying for it.

Completion of the Downtown Streetscape Master Plan is useless in attracting more people to visit the area. Investing in police presence (zero tolerance on drugs) and enhancing the feeling of security will be a better use of time and money.

I love the idea, especially if it deals with some of the mess downtown. I frequently see tons of garbage in front of closed/non leased buildings, glass ect. I hope this helps in refacing and cleaning up the area more than anything. Please keep some of the historic things as I believe there is value in it with the character of the town. I like downtown Woodstock and just want the best for the city.

You already got the benches back at market square, what else is SO important? Get rid of the homeless people downtown first then get a game plan into place.

I would really love to see the old pieces of the downtown remain (the walkways being old paving stone rather than sidewalks, the lampposts remaining the same) One thing I would love to see go is the bus stop that is blocking the view of museum square. It really took away from the charm of the downtown core, perhaps it could be moved in part of this project. I would much rather look at the beautiful old building and fountain instead of looking at a modern bus stop with different advertisements. Keeping the old charm of our beautiful town is important to me as a born and raised woodstonian who happens to live only a couple of blocks away. Modern doesn't always mean better! (I believe this especially about the sidewalks, paved sidewalks always have cracks and issues where as those stones have fewer issues, from my standpoint anyway!) I do also have a few suggestions about implementing a standard for the businesses in the downtown as far as physical appearance. Downtown Stratford has many rules and regulations when it comes to the businesses signs, building colours etc. which is how they keep the charm. I truly hope through this project you as the city council can look at towns similar to ours and follow their lead (Stratford, Galt, Paris) these are all downtowns that are always busy, where the businesses thrive and where everyone feels warm and welcome. Replacing the stones with paved sidewalk doesn't create that environment, building the charm does. Thanks so much for reading and taking these points into consideration! Why are we ignoring the homelessness problem? That is by FAR the biggest problem with downtown, and downtown will continue to be horrible until that sis addressed. Throwing money at the small issues, while ignoring the big ones is just pathetic.

I do support new lighting, sidewalks and the roads being repaired in the downtown core. The streets around Victoria Park are embarrassing.

Move the methadone clinic away from downtown and away from places you want families to go. The junkies shouldn't be part of the damn streetscape. I don't take my kids downtown anymore because I don't need them to see human waste on the sidewalks or people shooting up in broad daylight.

Find a way to keep the downtown cleaner. Sad seeing garbage all over the place. People who live on Dundas need to be more considerate. Smokers need to smoke at the back of the bars especially the one across from City Hall. Always a mess out there.

There should be more options! How are we to choose between \$500,000 and \$6.5 million!

Downtown needs investment and option 2 is the best for that. What it also needs is support for the restaurants and businesses that exist there to entice people downtown (Stratford has downtown dollars, would love a project like that)

Somehow, (maybe a liason with Central and WCI schools) there needs to be a clean up program with the city core- (community members etc.) the garbage is terrible.

There simultaneously needs to be plans in place to address the homelessness and drug use issues in downtown, so people will feel comfortable using the upgraded spaces. I have small children, and I like to bring them to events, but am always wary of the potential for needles, fentanyl residue, excrement, unpredictable people, and unsafe items downtown. I've lived in Woodstock most of my life, but the recent years have seen a big shift in the perceived safety and cleanliness in the downtown.

Allot money to recreational facilities ie indoor swimming /arena complex especially in northern Woodstock. City is sadly lacking

I agree with moving forward with the plan but as someone who doesn't live close to the downtown I don't foresee the improvements as a reason to head downtown. I think people either enjoy being part of the downtown atmosphere or not. I don't feel a huge dumping of money into these projects will increase people visiting the downtown long term. Perhaps at the beginning to check it out. I do believe it could use some sprucing up so I'm all in favour of moving forward - any kind of improvement anywhere is important.

I believe option 2 serves our local business owners, however something must be done to help with rents. Many of these buildings remain vacant because the rents asked are well above what is sustainable for a local business in Woodstock. The city ends up buying derelict buildings in the end, only to tear them down. This project (option 2 or 4) must be done in conjuction with preservation of existing properties. I know your hands are tied to some degree, but the plan may be more effective if we incentivize landlords to lower rents or subsidize rents. Maybe not a great solution, but without businesses downtown there is no tax benefit to this project. Love the idea though, and the time feels right as we are starting to see positive change downtown.

Other than improved lighting it is still too scary to go downtown.



There are lot enough businesses or restraints in the downtown to draw people there. Homeless people keep me from ever wanting to come there. All this work will just increase the homeless population in downtown. I am completely against spending any tax dollars downtown. We need tax relief long before this work should be accomplished.

I believe that this is an important project. The downtown seems to be gaining popularity, as a community of small businesses is beginning to populate the downtown area. It is exciting to see, and I think a project like this would do a lot to create a community and identity in Woodstock. Construction costs continue to increase, and while debt is not as inexpensive as it used to be (if the project had started in 2019 as planned, for example), interest rates are unlikely to drop. Delaying further will only make the project more expensive, and less likely to be realized. I personally would be happy to pay an extra \$25 in taxes to make this happen. Taxes are regularly increased by more than this, with a lot less payoff.

Above all else downtown feels unsafe and unclean. While improvements have been made and noticed by the public, Downtown Woodstock needs a facelift and a better perceived overall image.

We pay too high of taxes as is. Our community is not happy with our downtown, but there are other priorities. You seem to want to grow Woodstock. Deal with what comes with that growth first. Housing for the homeless should come before \$6,500,000 is spent on aesthetics. We want full transparency on costs. How many businesses do our city council own? How many rental properties? You can't honestly raise our taxes when interests rates and cost of living is where it's at. We also want to see the stats on this questionnaire. How many people gave feedback and how many were for or against. Downtown is important, but our quality of life in our homes is more important. Thanks for your time.

The landlords of those building which are in dire need of refurbishing must be compelled to renovate. It doesn't matter if the street is improved if the stores are not improved - first things first

In addition to the improvements we need to deal with the homeless situation. No amount of visual improvements is going to help with people being intimidated and not attending businesses.

You need more shopping stores, like department stores where you can by shoes, Beding, houseware, Boutiqes, something other Bars and Resturants. There is no Durgstores in that area. Not enough clothing stores for Kids and women and men, Bring more stores before you worry about the streetscape that all ages can shop..

Look at how Stratford has developed. Woodstock downtown is so run down. You can also do paid parking and other things to raise funds to better improve the city.

Creating a walkable (and bicycle friendly) downtown is important to our community. It brings our community together and provides a scene for culture to develop. Creating a more vibrant downtown will be a point of pride for the town of Woodstock and help local businesses thrive. Importance should be placed on developing the unused space next to Habitual Chocolate and the vacant lot next to Prime Barber shop. Well planned mixed use residential and retail developments would bring more business opportunities and provide much needed housing close to the downtown core. Thank you for engaging the people of Woodstock in the decision making process and providing this platform for citizens to speak up.

Suggestions only. Remove or reduce on-street parking and increase conveniently located parking lots. Maintain free parking for Woodstock/Oxford Co residents. If downtown charging stations are being considered, they do not have to be in prime locations.

Feeling safe and not harassed could still be an issue regardless of what is done to the appearance of the downtown unless other issues are being addressed as well.

Paving stone sidewalks are not safe for handicapped individuals- wheelchairs, walkers, sight impaired. Recommend that sidewalk design be referred to a committee of citizens with appropriate expertise to review.



I agree that we need better sidewalks and lighting however as long as the loitering goes in downtown I personally don't feel safe walking down alone in the daylight

The plan needs to include more Ontario Native trees and Ontario Native perennial plantings (easy to maintain, drought-resistant, adapted to difficult growing environments) as well as a community food garden/food forest maintained by volunteers that would provide food for the community in partnership with the library's seed collection, Woodstock Horticultural Society & neighbourhood schools. Regreening the downtown increases enjoyment of the space, provides food for insects/birds, provides a sense of belonging for the community, and provides food for the residents that may not have access to green space at their dwellings for gardens.

Something needs to be done to make people feel safe to go downtown again. The number of homeless people is a deterrent. The money could be spent on other more inclusive activities for all Woodstonians. Maybe council should consider building a new police station with that amount of money or getting help for the officers off on PTSD rehabilitated and back to work which would save taxpayers money!!

What is the City's plan to tackle the homeless crisis? Beautifying the Downtown is great, but if it becomes overrun with vulnerable people with nowhere to go then it will not achieve the goal of bringing everyone together to use the space and boost Downtown businesses. In the end, people need affordable homes more than a nice place to gather...

When I lived near Victoria Park for 46 years, I walked to the Library and also downtown several days ech week. Since moving to the northeast just south of Pittock Lake, I have to drive so do not go there as often as I used to.

It's important to improve the streetscape of downtown but it is also important to update zoning bylaws to ensure more density within the city centre. This a long with increased events designed to bring people to the downtown would help create a livable, vibrant and commercially productive downtown.

In this economic climate downtown businesses can not afford disruption. This unnecessary work will see detours away from the core, side walk and street closures which will affect businesses. Woodstock tax payers can not afford another tax increase in this econmomic climate

The time is now. If we build it - they will come. And likely the street people will leave. Have we checked with other municipalities how these large scale downtown projects impacted the homeless situation? Kitchener and Cambridge have done significant work in the past 10yrs. Can we reach out and see the outcomes ???

We really should be focused on creating mental health, primary care and outreach/ homeless services before trying beautification. We need a homeless shelter. Most complaints about downtown and Woodstock in general is not lighting or sidewalks, it's transient populations roaming streets without enough supports.- William Homerston

Festivals in the downtown are a horrible idea. Nothing like getting scorched by hot asphalt and sun. Victoria park needs ball diamonds removed and bandshell and washrooms installed. Trees make for a nice atmosphere for a festival and pro ide shade.

I like the idea of making room for patios I believe some consistency on how they are displayed would be nice A plan for a Xmas market in the town square at the museum would be wonderful during the holiday season Refer to almost any small German or Dutch town during the month of December

We do not support as we feel it will invite more homeless people to our downtown area and make it even more inaccessible for actual taxpayers- however we would like to see more parking- the removal of or changing of the bus stops because valuable parking spaces are being occupied by theses bus stops and parking greatly reduced- also the empty lot next to Delights Bakery needs to be addressed-perhaps a parking lot?



The reason I don't support moving forward with the Streetscape plan is because underlining issues don't involve infrastructures or sidewalks. Us as the community don't like to go downtown unless needed due to the overwhelming homeless and drug users. My number one concern would be to direct funding into getting them help and relocating the Methadone clinic or remove it completely. I can't go to the bank without worry that I will be confronted by someone. My second concern is the costs of new business coming into downtown with the cost of everything on the rise it's almost unaffordable for new or small business to open up shop. Unless it's a franchise of some sort. Another concern would be the lack of social interaction and safety in downtown. The number of \$300,000 a year to have police patrolling downtown doesn't seem realistic to me. First off they'd need to be there at the right time of any incident and also they don't seem to in force the no Loitering laws. But again this goes inline with my first issue about the homeless and drug users. My thoughts are that the tax payers are going to spend all this money on revamping the "look" of downtown and the outcome will still be the same with vacant buildings and still being unsafe for families to shop downtown.

We probably go to the downtown area involved an average of once a week. If it were a more attractive, welcoming place we would be there more often, as we believe others also would. We think that the planned improvements would attract/encourage more businesses to locate there and this in turn would lead to more use of this area by the Woodstock community. Some thought should also be given to improving the appearance of many of the buildings (at least the facades) in this part of the downtown area.

Increase housing close to the core will bring more people downtown to restaurants and activities.

Spending this money on downtown is not acceptable. We need better merchants and need to deal with the houseless situation. Trying to beautify our downtown without fixing these other problems is not going to make people feel safe in downtown core and will not bring in new business. Especially with our businesses now struggling. Banks can't even allow their customers into abm after hours. This is a terrible idea.

If the methadone clinic was moved closer to the homeless center (east of town) and out of the direct downtown corridor I think it would help an immeasurable amount. Being located directly across from museam square is not the best place for it regardless of how many police officers are employed and mental health outreach programs are created.

The tax payers are going to be hit extremely hard this year between County, City, School Board and probably Police...we can't take much more. My taxes went up \$500 last year and if this is included in the budget it will probably be \$1000. My pension's don't go up that much!!!

I don't think the issue is sidewalks and seating/lighting. I recently moved here and the issue is just creating a better environment for the homeless. They are the major issues here many buisnesses don't want to be here be they spread themselves across the downtown core and cause issues. Some if which many of us fear for break-ins and noise issues.. They leave garbage and pysh large carts around the core which doesn't look too inviting when coming into town..

Work on addressing drug use on our streets and people leaving drug paraphernalia around the downtown, people deficating and urinating on Dundas street. Work on homelessness and theft in town first.

The street scape master plan alone will not generate more traffic to downtown. Currently as it is standing, the downtown has very little to offer Woodstock residents, or anyone visiting from out of town. The homeless situation downtown is enough to make people weary of visiting. The lack of cleanliness amongst other businesses in the area and lack of options is also a deterrent. The downtown core is lacking quality of shopping/food/entertainment for our community.

Better bicycle locking infrastructure. Like bicycle rings at regular intervals, so people can run errands and not worry, as much, about theft.



All you want is for people to shop downtown. There is NOTHING TO SHOP! It's boring! Be like London and put on events. You don't need to fix anything except creating community days. You've got nothing going on, this town sucks!

with all the new growth in the city we need to improve downtown. It is a terrible sight to travel through. Woodstock can be better than what it is right now. Clean it up and get a better reputation.

We pay enough in taxes as it is, that won't fix the homeless issues and will encourage me to move out of town

My issue with downtown is the condition of the closed businesses. There are spots between light street and vansiitart that are covered in shredding chipboard. It's so dingy. Make property owners maintain a minimum standard.

Streetscape is important feature of the built environment we create, if we want to invest in better mental health, better physical health, improved social connections and a better or increased sense of belonging than this project should be in the top 10 projects for your budget. This project shouldn't be viewed as optional but vital to the fast growing communities of Woodstock.

There are way more important issues to spend the existing money on . You need to make downtown a SAFE place to visit , so install cameras , add security to encourage good citizens to visit the downtown... Nothing wrong with museum square now , add more picnic tables and sun shades (due to NO shade trees) so people can enjoy eating outside..

Master plan is outdated now that the city owns the liquidation centre property, 478 Dundas. Adding park space to the empty lot between this building and city hall is a bad idea. Open up the entire space, do something substantial and special. Reroute truck traffic so that it doesn't come down Dundas, create a destination, a gathering place where you want to sit outside and embrace the beauty of the community. Prioritize pedestrians over cars. Add green space. Add water features and sculptural elements. Add places for children to play. Add a square where restaurants can open patios. Think bigger. You don't need a consultant to do this. Just do it.

Look at the alley behind coffee culture and spend money to buy some bus tickets. Address this problem it's the main issue with the downtown core.

Downtown Woodstock is a historic place and does not require sidewalk or lightning. It requires taking care of the drug addicts and homeless people who are terrorizing the visitors and local business owners. Cleaning downtown from outside, but not taking care of the core problem is not going to fix Downtown issues

Find ways to make it a less scary place to go. Also make the free parking three hours instead of two so folks can both shop and have lunch in a relaxed manner.

If going ahead please make sure your tendered items are from Canada for your streetscape lighting and bollards or anything else. And If the shop drawings don't already support that please revisit. You want people downtown, support the vendors that are already local.

Part of me feels a better option is to fix the sidewalks which has zero impact on taxpayers. But I'd like too see the downtown improved slowly so the impact financially isn't so bad for taxpayers and then if plans need to be tweaked as you go they can be. No matter how much you beautify the downtown you need to make sure the homeless don't take it over and ruin it as well for the tax paying folks of the City. It's a tough spot and no matter what people are going to complain.

Option number 1 is the only thing that is reasonable and could be argued necessary! The rest of it is a waste of time and money! It won't make an actual difference in either bringing people down there or helping businesses make any money! It is the same as "downtown" in every city.. put the money to better use please! Kind of a waste of taxpayers money to be honest!



I do not fully support the proposed streetscape master plan. I believe we need a plan that increases walkability even more. We need more green space, not just planter boxes. We need permanent ares for native gardens that are not constantly rotated with "seasonal plants." We need less traffic on Dundas in the downtown, and more space for the community to exist without the emissions, noise, and disruption from single passenger vehicles.

I think the whole street scape thing was a way to get the city all hyped and sway votes, taxes, population, etc. it doesn't look good that a city now has to reel back in the line like this. I have lived in Woodstock most of my life, work for the government, live in Woodstock and am raising children in Woodstock. Woodstock has changed and grown exponentially as we all know. Funneling money into a cute street scape is not what I see as necessary for OUR town. Woodstock has major potential for growth and can hopefully maintain its "small town charm", which includes unique shops, cafes, restaurants and community events. The downtown area of Dundas St is not a great place to hold such events. Residents are scared to attend downtown. We are scared to walk the sidewalks and have a run in with a homeless drug addict who almost always behaves inappropriately and dangerously. These folks have been brought to our city from neighbouring Police Services and dropped off, because we offer assistance to them. Let's not forget the drug paraphernalia and random stolen belongings that are left lying around, of which the City Works and Police are left to clean up. That is a wonderful waste of EMERGENCY resources. Let along the number of drug related, theft, mischief, and assorted disturbances that 90% of the time involve these folks. Tax paying citizens are suffering. I am fully aware that this issue exists in nearly all cities. I feel the folks who are out cleaning the downtown most mornings are some of the cities heroes! City of Woodstock taxes are beyond too high. Any improvements must be done with zero-minimal tax implications. We can no longer afford to live here....raise our taxes and we are moving on out.

Something needs to be done about these issues before people with families will go downtown to shop.

The sidewalk repairs should be taken care of as necessary for safety. I honestly doubt spending the money on Streetscape plan is not going to bring people to the downtown. We need more police foot patrols to curb homeless from hanging around firmer consequences for ruining public property.

At this point where we have so many homeless people in Woodstock, renovating the downtown area seems the least of our concerns. I do love what the City did to improve the flow of traffic. However, we now need to focus on solutions for affordable housing and making our city less appealing to drug addicts.

Spending money on downtown when no one wants to go there because it's all weed shops and drug addicts hanging around makes little sense.

Changing the streetscape will not address the homelessness situation and the drug use that happens in the downtown. People will still feel unsafe and complain about the downtown. Spend the money on a Consumption Treatment Site which provides wrap around services instead of concrete.

Until something is done with our homeless population hanging out in the center of town and sleeping in storefronts the only thing that should be done is sidewalks and lighting. Money should be put into homelessness. They are the reason people aren't coming downtown

Downtown needs to be SAFE. That's the biggest concern (and we all know this). Maybe put some funding towards more on-foot officers 24/7. I'm a 30 year old woman and I would never walk downtown now, even during the day.

More mid-rise residential units to fill in gaps where buildings once stood, bringing more people to Woodstock's downtown, an already built up area. We should be doing everything possible to build more residential units within Woodstock instead of continuing to sprawl on prime agricultural land. If we want people to spend time in Downtown Woodstock, we need more People living within it and around it. If you have to drive 10 minutes from the suburbs to get there, chances are those residents might just drive somewhere else.

Not just this but trying to find a better solution for the business owners and parking. I park every day in coles walkway because it's close and a safe walk to work. We have brought it up to the mayor, city bylaw and nothing is done. Let alone even emailed back. Can we not make an option for the business owners in that part be able to buy a parking pass so we are not having to walk blocks and blocks at 11pm when we are trying to leave work. Getting tickets regularly Is getting old and very off-putting for us business owners.

Quite honestly, until more work is done to help the homeless population, there is no sense in spending any money on upgrades. Money would be better spent supporting food banks and homeless initiatives. The budget should already reflect improved lighting, and cleaning up areas of concern.

Complete Museum Square before Streetscape plans.

This has waited long enough, it's time to move forward with this project.

If you are going to invest in downtown please make a long-term commitment and plan to properly look after it.

Homelessness. How does this beautification plan address the people who are without homes and nowhere to go? It's time to stop saying it's not a problem for municipal government and just buckle down and help people. Spending money on helping people who are homeless would be a far better use of taxpayers' money that making the street a little more pretty. Find more worthwhile goals. Do better.

More support and encouragement for diverse small business to join the downtown. Not chains. Better property tax rates. We need restaurants, bars (not sports bars!!) and shops. I look at the diverse offerings of Stratford and would love to see more businesses like those but here in Oxford county. There are many ambitious, smart and enthusiastic people in Woodstock but the financial and lack of foot traffic issues are a huge barrier for them to take a chance. How do we make people want to come downtown? If we don't figure that out what's the point in creating a more accessible downtown??

Woodstock is a huge hockey and farming town and we should be marketing it that way. What about putting a city run outdoor rink that is electrically cooled so it is open even in warmer weather downtown. This transformed downtown when I lived in Brantford.

Can adding an outdoor recreation space in the center of downtown be considered? Possibly and outdoor roller rink that turns into an outdoor mini ice rink. Maybe a park next to it and spots that food trucks and vendors can park. Woodstock lacks activities downtown to drawn people to restaurants and shops. Similar styles can be found in Hamilton or brantford.

No matter what you do, or how much money you spend, people and businesses will not come downtown until there is more law enforcement and common sense enforcement of the vagrancy and criminal activity issues. With the people of Woodstock already facing the highest tax increase in long memory, Council needs to be extremely choosy in how they wish to add more debt to our already heavy burdens.



This plan is a waste of money because it is focussing on things that are NOT the real downtown issues. This will not draw people downtown, will not help the business, and will just add tax burden to already overburdened taxpayers. If you want to spend money, spend it on a parcel of land where a homeless encampment can be allocated to. With a destination, you give the police back their power to enforce the relocation of homeless away from downtown, private property, parks and trails, and this city will become safer, people will be more comfortable to come back downtown and start enjoying the city again. 3. Businesses need to be attracted to the downtown area and a plan needs to be developed and put into place, include all stakeholders. 4. Complete and enhance the empty lot beside city hall. 5. Add seating to Museum Square, and where the theatre was located. 6. Enquire whether the Medical Clinic can on a side street that allows privacy for those needing that support. Addiction is seen across all economic levels in our city 7. Woodstock needs to a plan to reduce homelessness that will reduce problems in the core are and throughout the city. Be strategic in meeting our difficulties.

I choose to skip downtown when possible in order to avoid interactions with the addicts and the homeless. Until there is some resolution in this regard I don't believe spending a lot of money to window dress the downtown makes economic sense.

Stop knocking stores over

I feel that the money should only be spent on sidewalks and necessary lighting to keep it safe and no painting buildings or upgrading the park area at this time

I feel the city should just do the sidewalks and necessary lighting along the streets to keep the streets safe for people to travel on and not spend the money on painting buildings or the park area at this time

How could we not make our downtown core safer and more inclusive for all of our Woodstocktonians

It isn't just about how it looks, but what draws people to Woodstock. Which is currently, nothing. Take a look at how other small towns draw business and find more opportunities to create something worth coming to. Also, we have a safety concern in this town with drug users and violent acts. It isn't safe for our children/teens to be uptown unsupervised. Something needs to be in place. From discussions I have had with fellow Woodstonians,. two of their biggest concerns with downtown Woodstock are the Meth Clinic and the drug culture it invites to the city's core and homeless people situation. Sadly, their presence in the area helps keep people away. Until these problems are seriously dealt with any cosmetic changes would be akin to putting "lipstick on a pig"

Concil should also access accessible store fronts. I can not enter a numerous business because of steps to get into them. Additionally council needs to impose city by-laws on buisness so they fix decaying store fronts, there's an entire page of maintenance by-laws that seem to be overlooked.

Complimentary services need to be increased due to Woodstock being where all essential services are for oxford county. Maybe not in the Downtown but in current vacant lots that the city may have access to.

The reasons I do not go downtown has nothing to do with the sidewalks, seating or lighting. I do not feel safe, Woodstock has a drug issue and a large population of those suffering congregate downtown. Move the methadone clinic out of downtown, and don't waste tax dollars on a non issue.



Hopefully if the city does anything in the downtown, they remember and take into consideration that the downtown reaches further then just around museum square. Do more to address the drugs and homelessness so I actually feel safe walking downtown and surrounding area. This goes for both daytime and night time. I can not walk the streets alone comfortably as a female in her late 20's.

There must be a way to prioritize this without the City funding this project through debt. Maybe a 5-year plan includes \$500,000 per year with capital reserves. We are not doing the residents of this city any favours, incurring a 20-year loan to complete this project and sending the wrong message to residents. Capital reserves are in place to avoid debt. If we want to teach Canadians strong financial literacy skills, the teaching should start with federal and provincial budgets and city planning.

Why the heck did you put in paving stones in the first place? Every homeowner knows they require constant maintenance. Why weren't the curbs poured properly?

The issue I feel is not the landscape but the fact that people do not feel safe walking down town. This is due to the individuals using drugs in open spaces. I have to lock my doors if I am sitting in my car and will avoid stores that have people using. If we address this problem first downtown could become the heart of the community without a 10 million loan. You could complete this and we still not feel safe if people are high on the sidewalk or in the doorways of businesses. We do not feel safe.

Deal with the homeless people downtown. People are afraid to go to businesses when someone is shooting drugs in the entranceway. The garbage and cigarette butts are an eyesore.



I'm not sure if this is a city council topic or only for store owners but what about actually having accessible entrances into the stores? I don't have a disability but I have a son that is 2 and another son on the way. When I was on maternity leave last time I wanted to support many local businesses downtown but found it very difficult to go with a stroller. No automatic doors, many locations with steps to enter. With small children they want to touch everything too so I would then not want to bring him but that limits my available times to go when my husband isn't working. Just a suggestion to bring forward especially if there are others who do have a disability that want to enter these businesses too.

The city needs to support businesses to move downtown through reduced taxes . The Methadone clinic needs to move away from the center of this project or nothing will change. Greater police presence in the core area is needed.

why wouldn't we start with the redesigning of museum square, that was 1.5 million and would have the most impact to our downtown

Streetscape Master Plan does not clean up the downtown core of crime and homeless. Fix that problem first, or at least have a plan to fix it.

I am supportive of the plan for our community - and also to be honest, I feel that regardless of work done my habits will remain the same. I go downtown generally for specific reasons (appointments, visiting a particular store etc). I avoid downtown if I don't have the time or energy and shop online instead. I never go downtown just to walk, window shop or attend events.

The city staff do not get the recognition they deserve regarding cleaning up the downtown core. The city counsel needs to go to our local parliament and have them bring it to provincial level regarding drug use/abuse in the downtown core. Working for the city, we pick up A TON of needles - we have lives outside our jobs and should not be risked by having to clean up needles. It is so unsafe no matter how much training you give supervisors/temporary staff/students. At the end of the day they would rather go home to their families, healthy, not put at high risk of being stuck with a needle and contracting a life altering disease like HIV. Flowerbeds and garbages are great hiding places for needles. Would you put your hand into one while wearing a "puncture resistant" glove? Probably not. Removing benches in Covid did help - I supported that 100%, it made staff safer. Along with that, every staff member working downtown, especially students, should be wearing a loner device regardless of time of day or number of people in their group. The number of times I've had to call police dispatch is crazy. There was never a moment where I actually felt safe downtown. Counsel needs to take that seriously and provide loners to students, time of day and number of students is irrelevant

Spending any money on a facelift is not going to draw any new stores to downtown because in the end it comes to cost. Another note is since redoing the bus routes, the city has taken away ample parking downtown on dundas st which isnt great either. thank you for the oppourtunity to provide a comment I just feel that spending any money on a facelift will not help anyone. another thought that comes to mind is seeing the idea of putting back brick paver crosswalks, its such a horrible idea considering they were just removed a few years back and now the road is much smoother.

Moving the meth clinic out of the downtown core and adding more regular "beat" officers would improve the downtown immensely. Apartment buildings in vacant or unused retail space would help also.

Completing the Streetscape master plan in full, or in phases is most preferable. The merits of the plan will be self evident once it is complete in full or in part. Please don't stop investing in the downtown like this. Revitalizing downtown cores is important and has many benefits.

Don't bother. As someone in their mid 30s with a small family I never consider "downtown Woodstock" for anything aside from a road to drive through. Spending nearly 10 million on a project which essentially just puts lipstick on a pig doesn't make me want to venture down to the downtown core. It offers essentially nothing.

Didn't we just put millions into downtown? I feel it's like throwing money away at this point.

You can spend all the money you want on sidewalks and construction and it's not gonna improve the downtown one bit. You have to do something about the homeless first! What's your plan on the homeless?

There are more important issues to be dealt with downtown. I'm very leery of going downtown due to the homeless and the drug trade that's going on. Very frightening for families. Theft is rampant in Woodstock due to these two issues

Fix the sidewalks. The road, lighting and on street parking will not bring people downtown and long duration construction will devastate local businesses. Focus on the redevelopment of Museum Square and increasing housing density in the downtown. Redevelopment of 16 Graham Street is an excellent start. More people living in walking distance to the downtown is the key to a successful downtown and will support the local businesses. Look at Brantford's approach with Harmony Square and now the proposal for 50 Market Street South (Freshco plaza across from the Brantford Casino). It is an extremely poor decision to reconstruct the downtown before the plan and investment is in place to provide quality housing units in the downtown. Quality housing units will attract the desirable population to provide the revenue local businesses need to thrive and will attract new businesses to invest in downtown Woodstock.

I feel as if we need to spend more money on housing those most vulnerable before we take on this kind of financial responsibility.

Before under taking any downtown improvements our councilors need to resolve the primary concerns regarding the safety and appearance in the downtown area due to the homeless and drugs all being a major detriment to visitors and residents.

It is not safe to be downtown. Area needs to deal with downtown deterrents & vagrants. Strong measures need to be applied for functionality before money is spent for any downtown activities.

Until you address specific zones of activity which can attract people in a larger scale you are wasting your time. You need development that will attract senior citizens, college students and fitness enthusiasts. Without having core economic drivers to attract people and generate economic activity, you are really wasting time and money.

Your first priority, even before the beautification, should be SAFETY. As a 21 year old female, I NEVER feel safe in downtown Woodstock due to the homeless population. Relocating the methadone clinic should be a number one priority so that you can attract a younger population. That is where the money is, especially with Fanshawe being in Woodstock as well. Other college and university towns have capitalized off of their young population. You need to do the same. It will NOT matter how beautiful you make it if people don't feel safe in the area. I know that it is a sensitive subject, but the safety of your younger population should come first.

The downtown revitalization project is, in my opinion, a waste of money if Woodstock locals cannot enjoy it without seeing people do drugs on the street and be harassed for money by homeless people. Waste receptacles do not get used by the homeless and the homeless people just go through them and create a mess that just litters Woodstock. Until the homeless population is effectively managed and the drug addicts are moved out of the downtown, I don't see the point in renovating the area for it to not be used by local taxpayers. I also believe that the downtown core needs a grocery store so that the locals living in that area are attracted to the area on a regular basis rather than driving to the other side of the city to run errands and concentrating our local economy to the big box stores on Norwich Avenue and spread the traffic more evenly across the city.
