On Tuesday, June 28, 2022, the jury recommendations from the Inquest into the deaths of Carol Culleton, Anastasia Kuzyk and Nathalie Warmerdam were presented. In total, 86 recommendations for change were made, speaking to oversight and accountability, system approaches, collaboration and communication, funding, education and training, measures addressing perpetrators of intimate partner violence, intervention and safety. Since then several communities, including Lanark County, Renfrew County and Ottawa, have declared intimate partner violence an epidemic based on the aforementioned recommendations. We are hoping to speak to city council about joining with the above communities and declaring intimate partner violence an epidemic.

### **Annual Femicide List**

#### November 26th 2021 to November 25th 2022

OAITH's Annual Femicide List includes a gender-based killing of a woman, child, trans woman, 2-Spirited Person, or gender nonconforming individual where a man has been charged in relation to the death(s) or has otherwise been deemed responsible (murdersuicide). Femicide, most broadly defined, means the gender-based killing of women and girls and the most extreme form of violence towards them. In the Canadian context, the killing of a woman or girl could lead to Criminal Code charges of first or second degree murder (where the killing was intentional), manslaughter, or criminal negligence causing death.

OAITH reviews mainstream media reports of femicides involving women, children, trans women, 2-Spirited Peoples and gender nonconforming individuals. This list includes femicides that have occurred in Ontario during a 12 month period from November 26th through to November 25 of the following year. Annual reports are released on November 25th, the International Day for the Elimination of Gender-Based Violence. The list relies on mainstream media sources and other publicly available sources. This means the list is not exhaustive and may include errors or omissions. It represents only a snapshot in time of public reports of femicides for the previous year at the time the list is published. This annual report is not updated to reflect criminal justice outcomes after the report has been published.

Evolving definitions of femicide attempt to include and represent the diversity of gender identities, relationships between victims and perpetrators, and motives for the killings. Our Annual Femicide List includes only those femicides where men have been charged with a criminal offence or deemed responsible (murder-suicide) and where there is a media report. OAITH reviews and analyzes hundreds of mainstream media sources (i.e. local and national newspapers and TV clips) every year based on our definition of femicide and the victim/perpetrator relationship. Relationships include a current or former husband or boyfriend, a brother, son or a nephew, a male coworker, neighbour, friend or acquaintance, or another man closely known to them. Where the relationship between the victim and perpetrator is not known (or not released), but media reports indicate that a woman was killed as a result of a violent gendered crime, that woman's name will be included on the list.

Every year we release our Annual Femicide List based on mainstream media reporting to ensure that we remember the victims, bring attention to the violence women, girls and gender-diverse people experience, and take action to move our list to zero through femicide prevention. OAITH works in partnership with Dr Mavis Morton of University of Guelph to track, analyze and educate the community about femicide.

He had been convicted of threatening to kill an OPP officer and his family, assaulting his former girlfriend, breaking and entering, uttering threats, and failing to comply with a restraining order to stay away from his previous partner. He had recently received an early release from custody, citing concerns for inmate safety related to Covid-19.

Femicide Type: Known Cause of Death: Asphyxiation





## **37. Anne-Marie Ready, 50** June 27, 2022, Ottawa, ON

Anne-Marie has been described as a kind hearted and selfless mother, friend and colleague. She will be remembered as a team-player and an inspirational leader in her family and community. Anne-Marie shared a love for karate with her daughter Jasmine, and the two had recently received their black belts. Anne-Marie was a dedicated mother and also worked to obtain her PhD in international business. At the time of her death, Anne-Marie was employed by Global Affairs Canada and had previously worked internationally with the Canadian Embassy. Anne-Marie will be dearly missed by her husband, family members, friends and colleagues. A male neighbour, who had a history of violence towards women, including towards her daughter Jasmine, killed Anne-Marie and Jasmine, before being killed by police. Anne-Marie's 19 year old daughter, Catherine, was also injured but survived the attack.

Femicide Type: Known Cause of Death: Trauma

## **38. Jasmine Ready, 15** June 27, 2022, Ottawa, ON

Jasmine will forever be remembered for her kind smile and her compassion and love for all in the world. Jasmine was a loving sister, daughter and friend to many. She had recently graduated from the tenth grade and had spent the last three years working towards obtaining her black belt. Jasmine will be missed greatly by her father, sister and many other family members and friends. Jasmine was killed, along with her mother, by a male neighbour who had a history of violence toward Jasmine and other girls. The perpetrator was killed during the attack by police. Jasmine's sister, Catherine, was also injured in the femicide but survived.

## 39. Sharon Richards, 61

January 5, 2022, Newmarket, ON

Sharon has been described by her neighbours as friendly and a mother of two who was the matriarch of her home. Sharon will be missed greatly by her family, friends and her community. Sharon's 25 year old son was charged with 2nd degree murder and arson in relation to his mother's death. Media reports have indicated that Sharon's son has a history of violence and had previous charges for uttering threats and assaulting one of his siblings with a knife.

Femicide Type: Family Cause of Death: Trauma

**40. Taffash Riley, 14** February 1, 2022, Mississauga, ON

Taffash was a grade nine student at the time of her death who had a deep love for cooking. She will be remembered as a gentle spirit and a beautiful bright soul that was taken too soon. Taffash will be missed dearly by her parents, brother, her friends and her extended family and community back in Jamaica. A 19 year old man has been charged with manslaughter in relation to this femicide.

Femicide Type: Unknown Cause of Death: Shooting





#### **41. Angelica Sig-Od, 20** August 26, 2022, Toronto, ON

Angelica will be remembered as a kind and loving daughter, niece and friend to many. Angelica has been described as a warm and kind young woman, who shared her love and talents for music with the world. Angelica had been studying in her final term of the Flight Services, Operations & Cabin Management program at Seneca College and hoped to become a flight attendant to travel the world and experience new cultures. She will be deeply missed by her family, classmates and community in Toronto and back home in the Philippines. Angelica's father has been charged with two counts of 2nd degree murder in the deaths of Angelica and her mother Elvie.

Femicide Type: Family Cause of Death: Trauma

42. Elvie Sig-Od, 44 August 26, 2022, Toronto, ON

Elvie will be remembered as a devoted mother and member of her local church community. Elvie has been described as a kind and gentle woman and was working as a support care worker at the time of her death. Elvie will be deeply missed by her local church community and many friends and family members in Toronto and in the Philippines. Elvie's 46 year old husband has been charged with two counts of 2nd degree murder in relation to her and her daughter's deaths.

Beverly partner's grandson has been charged with two counts of 2nd degree murder in relation to Beverly's and her partner's deaths.

**45. Danielle Strauss, 38** November 10, 2022, Hamilton, ON

Danielle will be forever remembered by her daughter, other family members and many friends. Danielle enjoyed spending time with her neighbours on outings or playing bingo and loved to laugh. She will be forever missed by her loved ones, friends and community members. No charges have been laid in relation to her death, however, police have indicated that they are looking to speak with four teenagers, two male youth and two female youth in relation to this case. Neighbours have reported that in the months before her death, two male teenagers had moved in with Danielle.

**46. Vanessa Virgioni, 29** June 17, 2022, Brampton, ON

Vanessa will be remembered as a caring and devoted mother, daughter and friend who showed love to everyone around her. Her loved ones have described her as a kind soul, who had a smile that could light up the entire room and who was a beacon for equality, human rights and freedom. Vanessa will be forever missed by her young son, family, friends and community. Vanessa's ex-boyfriend has been charged with first degree murder in her death. Media reports have indicated that her ex-boyfriend had a previous history of violence towards her and had previously pleaded guilty to break and enter, assault and threatening death.

As highlighted in the January Monthly Femicide Report, half of all confirmed femicides this month were perpetrated by a family member, more specifically by the victim's adult son. While femicides in Ontario are most commonly perpetrated by intimate partners OAITH has continued to monitor increasing rates of family perpetrated femicides, which have been most commonly perpetrated by the victim's son. In order to ensure all types of femicide are addressed within violence intervention and prevention initiatives it will be imperative that these initiatives consider the multiple sources of gender-based violence (GBV), including not only current and former intimate partners but also family members such as a father, brother, son or nephew, as well as other known relationships such as a landlord or co-worker. For example, many existing GBV risk assessments and screening tools currently focus on intimate partner violence but ensuring all types or sources of violence are evaluated within risk assessments could ensure that an individual's risk level is not unintentionally mitigated. Furthermore, it will be important to ensure that a wide range of services and systems, such as the healthcare and mental health, child welfare and criminal justice systems, have the capacity to assess the risk of all types of violence and lethality. This will ensure that survivors who may be experiencing violence not perpetrated by an intimate partner, and who may not already be connected with traditional GBV services, can be connected with local services and supports that can collaboratively work to mitigate risk and increase safety.

On February 9th, 2023, the Chief Coroner for Ontario announced that an inquest will be held into the death of Keira Kagan. The announcement comes as the Domestic Violence Death Review Committee found that Keira was likely to have been killed by her father as a form of intimate partner violence perpetrated against Keira's mother and ultimately Keira (CBC News, 2023). Currently, Bill C-233 is in the final stages of debate within the Senate and if passed would include amendments to the Judges Act that would mandate training and continuing education on intimate partner violence and coercive control for judges (Merali, 2022). This will be a welcome change that has the potential to enhance safety outcomes for survivors by addressing stereotypes or preconceived notions among judges regarding intimate-partner violence and coercive control. Multiple systems could benefit from enhanced training on IPV and coercive control, as well as risk-assessment and safety planning, including lawyers, medical/healthcare professionals, child welfare systems and educational systems. Ongoing training could not only enhance capacity but may also facilitate enhanced system collaboration and communication regarding risk and risk management, and ultimately prevent future femicides from occurrina.

A number of prior femicide inquests have occurred in Ontario, with the most recent inquest taking place in June 2022. OAITH has created the following tool to track and monitor ongoing and repeat inguest recommendations: Inquest Recommendation Comparison Chart

Throughout the month of March, 66.7% of cases, police press releases and subsequent media reports did not provide information regarding the relationship between the victim and perpetrator. The lack of disclosure regarding the relationship may be due to pending police investigations, ongoing court proceedings and it may also be at the request of the victim's family. Based on media reports, there may be statements that suggest there was some type of existing relationship such as statements indicating there is no risk to the public and that the killing was a targeted or an isolated attack. The lack of disclosure regarding the type of relationship that existed between the victim and named perpetrator can have a number of impacts on both data collection, as well as on public awareness and understanding of the prevalence of gender-based violence (GBV). Within OAITH's 2021-2022 femicide data, in 21.2% of cases details regarding the relationship between victims and perpetrators were not provided within media reports. The lack of relationship data may ultimately impact femicide research and as a result rates of violence may be underestimated, such as rates of intimate-partner femicides or family member perpetrated femicides ultimately impacting public awareness and understandings of GBV. OAITH's Femicide Reporting Recommendations suggests the use of non-traditional sources of information to inform media reports, could include GBV experts and also family and friends of the victim who may be able to provide further context to the victim's experiences of violence. This recommendation could also be helpful in addressing the current gap related to the lack of police disclosure regarding the potential relationship between the victim and perpetrator.

# MONTHLY HIGHLIGHT

**WE COUNT** 

Throughout April, two confirmed femicides have been reported in Ontario. Additionally, one newly confirmed femicide from March was also identified through media reports. According to media reports, both of the femicides in April were perpetrated by the victims' adult sons. High rates of family perpetrated femicides continue to be reported over the last few years, accounting for 21% of femicides last year and 25.8% of cases the previous year. Since November 26, 2022 there have been 6 femicides that were perpetrated by a family member, most commonly the victim's adult son, although a grandson and father have also been identified as the suspects within two femicide cases. While details regarding these femicide cases continue to emerge, in at least two of the six family perpetrated femicide cases there was a documented history of violence by the son towards his mother, as well as towards other community members. While programs such as the Partner Assault Response (PAR) program currently exist to address violence within intimate partner relationships, these programs do not encompass other forms of gendered violence, including violence perpetrated by family members. This trend continues to reinforce the need for increased access to services for young men, within femicide prevention initiatives, that work to address and change harmful and violent attitudes and behaviours within familial relationship as well as intimate partner relationships.

Of the 86 recommendations for change issued by the jury as a result of this inquest, the first is that the Ontario government declare intimate partner violence an epidemic (Luke's Place, 2022).

This idea is directly replicated in the recommendations issued following the Nova Scotia mass shooting inquiry, which calls for a public health approach to be taken to violence against women and "stable core funding" for groups that help women survivors (Press, 2023).

Intimate partner violence (IPV) refers to any behaviour within an intimate relationship that causes physical, psychological, or sexual harm (CDC, 2022). The term "intimate partner" includes current and former spouses, dating partners, and sexual partners. IPV does not appear in every relationship in the same way. Physical assault, sexual violence, criminal harassment, threats of physical or sexual violence, reproductive coercion, spiritual abuse, cyber violence, emotional abuse, financial abuse, or psychological abuse are all examples of how coercive control can be perpetuated (Government of Canada, 2022). IPV can range from a single incident of violence that has long-term consequences to chronic and severe episodes that are endured for years. In many circumstances (CDC, 2022). IPV leads to femicide, which can be defined as the death of women and girls on the basis of their gender (Sutton, 2023).

It is estimated that one woman in Canada is murdered by her intimate partner every six days (Armstrong & Jaffray, 2023).

Intimate partner violence occurs in all settings and among all socioeconomic, religious and cultural groups. The overwhelming global burden of IPV is held by women. According to one study of IPV convictions in Ontario, 92% of offenders were men (Government of Canada, 2022). Data also reveal that women are more likely than men to be subjected to IPV with increased severity (such as being strangled, assaulted or threatened with a weapon, or sexually assaulted) (Sutton, 2023).

The Department of Justice Canada estimates that 7.4 billion dollars is spent on the aftermath of intimate partner violence each year (Sutton, 2023). This includes immediate costs (such as emergency room visits, involvement of police and the criminal justice

system) and related costs (such as loss of income, funeral expenses) and intangible costs (such as pain and suffering).

The Ontario Association of Interval and Transition Houses (OAITH) releases regular reports on femicides in Ontario. The most recently released report, spanning November 2021 to November 2022 showed 52 women and girls murdered in Ontario during that period (OAITH, 2023). The images portrayed behind me are of the 13 Ontario women that have been murdered by a current or former intimate partner in the first quarter of 2023. Please note that data from May has not yet been released.

A snapshot of Woodstock specific statistics has been included for your review in the material package we've provided.

2022 marked the eighth consecutive year of increase in police reported IPV in Canada (Government of Canada, 2022). This epidemic requires immediate responses from all levels of government. The consequences of IPV are long lasting and far reaching. These women are our friends, sisters, children, parents, colleagues, employees and employers. In spite of continuing progress in public education, there is still a stigma attached to being a victim of IPV, and many choose not to report because they believe their experiences of violence are a private matter, and that they may not be believed.

To date, 14 municipalities across Ontario have declared intimate partner violence an epidemic. A full list of these municipalities has been included in the materials we've provided.

Today, we ask that on behalf of the City of Woodstock that all voting city councillors and your worship, Mayor Jerry Acchione, approve the motion to declare intimate partner violence an epidemic. In doing so, the City of Woodstock will have the opportunity to demonstrate that we represent a community that is committed to ending violence in intimate relationships. This declaration will send a strong message to victims of IPV that they need not suffer violence in private; that they are part of a community that will stand with them, support them, and believes in their right to safety. This declaration will make it clear to our residents and the province that the City of Woodstock will not tolerate this violence in our community. **Thank you.
